1. Separate and distinct rates are to be tendered for each category of Scrap per Unit.
2. Price shall be for delivery Ex. our mills at Kareelakulangara, Kayamkulam.
3. GST/taxes and duties of the State/Central Government and local bodies shall be extra to buyer's account at rates ruling at the time of invoicing/dispatch.
4. The tender shall be sent only by Registered Post super scribing the Envelop "TENDER FOR SALE OF SCRAP" accompanied by a security deposit/EMD of Rs.10,000/-(Rupees Ten Thousand only) for Scrap in the form of crossed Demand Draft/Cash drawn in favor of the General Manager, Alleppey Co-operative Spinning Mills Ltd. and payable at Kayamkulam or can be paid directly to the Mills during working hours. In the absence of the deposit, tender will not be considered. The Security deposit is refundable to the unsuccessful bidders.
5. The bidders should remit an amount of Rs.500.00 plus GST Rs.90/- (Total 590/- Two Hundred and ninety-five only) as tender form cost while submitting the Tender. Tender form is available in our **website: www.acsm.kerala.gov.in** or can be collected from the Mill after remitting the tender form cost. Tender without EMD & Tender form cost will be summarily rejected.
6. The tender along with the EMD & Tender form cost should reach the Mills on or before **22 July 2024, 11Am.**
7. An auction will be held at 2.00 PM on 22 July 2024 before opening the tender. After opening the tender, the same auctioned rate and bid rate will compare and the highest rate will be considered if the rate is matching with the Market rate of Scrap.
8. It should be the duty of the buyer to take delivery of the allotted Scrap from Mills and arrange dispatch at his/their own cost.
9. Accumulated Scrap shall be taken delivery of within 15 days (FIFTEEN DAYS) of auction or scale order.
10. The Mills reserves the right to forfeit amount already paid if any including Security Deposit, and to dispose of the Scrap by private treaty or public auction without give in any further notice to the allottee failing payment in full and lifting

- the Scrap within 15 days of the date of receipt of the acceptance letter from the Mills. The short fall, if any in realization shall be recovered from the allottee at his/their own cost. The allottee shall have no right of whatsoever nature over realization in excess of the value of the allotted Scrap at the accepted rates if any.
11. The Scrap may be inspected on any working day between 10AM to 4 PM in the Mills and no claim for reduction in price or allowance of any description whatsoever will be entertained in regard to the quality of the Scrap once they are allotted.
 12. Security deposit of successful tenderers will be retained by the Mills as security for due performance of the contract. This sum shall be refunded on completion of the contract and payment of dues in full.
 13. Security deposit of unsuccessful tenderers will be refunded by means of crossed cheque/cash or directly from our office on submission of the receipt given to the Bidders.
 14. The security deposit is liable to be forfeited for breach of any or all of the conditions herein.
 15. The Mills reserves the right to appropriate for its own use whatever quality of and quantity of Scrap required for the Mills.
 16. The Mill reserves the right to reject any or all the tenders without assigning any reasons therefore.
 17. Each tender will be provided within 2 copies of the tender Schedule, out of which one copy should be returned accepting the terms and conditions, quoting their rate and signing at the place provided below with seal.
 18. Dispute arising out this tender, will be dealt with only in a court with Harippad Jurisdiction.
